For the handicapped that need further verifications, they must continue to apply for tax exempt approval with their handicapped certificate just verified before the valid period expires. Once the period expires, taxation will be resumed. 3. Due to change of applicable tax exempt reasons (e.g. decease of handicapped certificate owner, different household address between vehicle owner and the handicapped, the address of vehicle registration and household not being identical, handicap reasons vanished or resumed healthy, vehicle usage change or being transferred to other title etc.), the handicapped are not qualified for tax exempt, they must apply for resumption of Tag Tax payment status. 4.
